SECTION VI - HEALTH DATA

ROUTES OF ENTRY:eye/skin contact, inhalation, ingestion.

HEALTH HAZARDS (ACUTE, CHRONIC): CAUTION! May cause irritation to the eyes, skin, and mucous membranes. May cause irritation to the throat and gastrointestinal tract if swallowed. May cause respiratory tract irritation if inhaled. Contains Formaldehyde, which is a suspect human carcinogen.

CARCINOGENICITY: Formaldehyde **NTP?:** Suspect. **IARC?:** 2A **OSHA?:** Suspect.

SYMPTOMS OF EXPOSURE: eye and skin irritation.

MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE: Pre-existing eye, skin, gastrointestinal, and respiratory tract disorders may be aggravated by exposure.
