Section 4. First aid measures

Description of necessary first aid measures

Inhalation :

Get medical attention. If it is suspected that mists are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Move exposed person to fresh air. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Keep person warm and at rest. If unconscious, place in recovery position and get medical attention immediately. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours.

Section 4. First aid measures

- Ingestion** : Get medical attention if symptoms appear. Move exposed person to fresh air. Wash out mouth with water. Keep person warm and at rest. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Remove dentures if any. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. If unconscious, place in recovery position and get medical attention immediately. Never give anything by mouth to an unconscious person. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs.
- Skin contact** : Get medical attention. Flush contaminated skin with plenty of water. In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Continue to rinse for at least 15 minutes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves. Remove contaminated clothing and shoes. Sensitizer to skin. Sensitization may result in dermatitis. In the event of any complaints or symptoms, avoid further exposure. Wash contaminated clothing before reuse. Wash clothing before reuse. Clean shoes thoroughly before reuse.
- Eye contact** : Get medical attention if irritation occurs. Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open.

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see section 8).

Environmental precautions : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air). Water polluting material. May be harmful to the environment if released in large quantities.

Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Large spill : Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Wear appropriate respirator when ventilation is inadequate. Skin sensitizer Persons with a history of skin sensitization problems should not be employed in any process in which this product is used. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations.
